### ORDER:

In the Government Order first read above, sanction was accorded for a sum of Rs.43,00,072/- to ELCOT for maintenance of Secretariat Network (SECNET) at Secretariat for the period from 02.09.2013 to 01.02.2016.

- 2. In the letter second read above, the Managing Director, ELCOT has sent a proposal for release of a sum of Rs.1,63,80,880/- for renewal of Annual Maintenance Contract (AMC) for providing maintenance support with manpower to SECNET for a period of two years from 11.04.2016 to 10.04.2018.
- 3. The Government after careful examination of the proposal of the Managing Director, Electronics Corporation of Tamil Nadu Limited sanction a sum of Rs.1,63,80,880/- (Rupees one crore sixty three lakh eighty thousand eight hundred and eighty only) for renewal of Annual Maintenance Contract (AMC) for providing maintenance support with manpower to SECNET for a period of two years from 11.04.2016 to 10.04.2018 and release a sum of Rs.1,61,08,282/- (Rupees one crore sixty one lakh eight thousand two hundred and eighty two only) after adjusting the balance sum of Rs.2,72,598/- available with Electronics Corporation of Tamil Nadu Limited out of the funds sanctioned for the maintenance of SECNET for the period from 02.09.2013 to 01.02.2016.
- 4. The expenditure sanctioned in paragraph 3 above shall be debited to the following head of account:

"2852.Industries – 07.Telecommunication and Electronic Industries – 800. Other expenditure - Schemes in the Twelfth Five Year Plan – II. State Plan – JD. Assistance to ELCOT towards Tamil Nadu State Wide Area Network – 09. Grants-in-Aid – 01. Grants for Current Expenditure." (DPC 2852-07-800-JD-0919).

- 5. The amount sanctioned in paragraph 3 above shall not be paid in cash but credited to the following head of account by means of cheque in favour of Personal Deposit account of the Electronics Corporation of Tamil Nadu Limited:-

- 6. The Section Officer (Bills), Information Technology Department is authorised to draw and disburse the amount sanctioned in paragraph 3 above to the Personal Deposit account of Electronics Corporation of Tamil Nadu Limited.
- 7. The Managing Director, ELCOT is authorised to take appropriate measures as necessary for the successful implementation of the project in consultation with the Board. The Managing Director, ELCOT is also directed to send the physical and financial progress report of project every month to the Principal Secretary, Information Technology Department along with the details of expenditure and Utilisation Certificate.
