## ORDER:

The former Hon'ble Chief Minister of Tamil Nadu, among other thing, and has made the following announcement on 23.09.2016:-

"தமிழக அரசின் சேவைகள், சம்பந்தப்பட்ட துறைகளின் வாயிலாக, பொதுமக்களுக்கு, இணையம் மூலம் வழங்கப்பட்டு வருகின்றன. தற்போது, தொழில்நுட்ப வசதியுள்ள கைபேசிகளை பெருவாரியான மக்கள், சிறந்த பயன்படுத்தி வருகின்றனர். எனவே, அரசு சேவைகள் கைபேசி செயலிகள் வாயிலாக அளிக்கும் வகையில் –"அம்மா (Assured Multi-Modal Access to e-Services) இ–சேவை" என்ற ஒரு திட்டத்தினை செயல்படத்த நான் உத்தரவிட்டுள்ளேன். முதற்கட்டமாக 25 முக்கிய சேவைகள் இத்திட்டம் வாயிலாக வழங்கப்படும். இந்த கைபேசி செயலித் திட்டம் 1 கோடி ரூபாய் செலவில் செயல்படுத்தப்படும்."

- 2. Accordingly, in the letter 2<sup>nd</sup> read above, the Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) has sent a proposal to Government for implementing the scheme Assured Multi Modal Access to (AMMA) e-Services and development of Mobile Application for 25 citizen centric services.
  - 3. The salient features of the proposal are as follows:-

#### I. Introduction

A mobile app is a software application designed to run on mobile devices such as smart phones and tablet computers. As usage of mobile apps has become increasingly prevalent across mobile phone users, the Government of Tamil Nadu is keen to deliver e-Sevai services through the mobile platform also. Citizens will be able to avail services "anytime" "anywhere" through the mobile application. It will prove as an extended arm of TNeGA for delivering citizen centric services.

### II. Objective

The major objective is to "Enable the delivery of citizen centric services of Tamil Nadu e-District Suite through mobile applications".

#### III. Benefits

- a) Citizen need not necessarily visit the Common Service Centers for availing the e-District Services, especially those which do not require any submission of documents.
  - b) Citizen can avail the e-District services at their fingertips with ease and comfort through these mobile applications.
  - c) Citizens can track the status of their applications and of any e-District service and anytime through usage of the mobile application.
  - d) This would increase the reachability and availability of the e-District application.
  - e) The mobile application would be made available to different types of mobile users' including i-Phone iOS and Android Operating System (OS) based Smartphone's to support Android 4+ and i-Phone OS (iOS) 9+ users.
  - f) Users will be able to download the applications from their respective app stores and use the application with ease and comfort.

#### IV. Cost Estimate

A cost estimate for the mobile application development based on the above said features is prepared approximately at a cost of Rs.1.00 crore.

- 4. The Director e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) has further stated that the development of mobile application for the project will be implemented with the e-District project funds and no separate financial sanction of funds are required from the State Government for implementing the scheme. He has therefore requested the Government to accord administrative approval for the project.

The Government after careful consideration of the proposal of the Director e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) accord administrative sanction to Tamil Nadu e-Governance Agency for implementing the Assured Multi Modal Access to (AMMA) e-Services and development of Mobile Application for 25 Citizen Centric Services scheme at an estimated cost of Rs.1,00,00,000/- (Rupees One Crore Only) The expenditure shall be met from the e-District project funds.
- 6. This order issues with the concurrence of Finance (Industries) Department, vide its U.O.No. 11144/Fin (Ind) /2017, dated 06.03.2017.
