ORDER:

In the Government Order third read above, the Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) was appointed as Registrar for Aadhaar enrolment in the State and Tamil Arasu Cable TV Corporation Limited (TACTV) and Electronics Corporation of Tamil Nadu (ELCOT) have been authorized as the Enrolment Agencies for this purpose.

2. On 23.09.2016, the former Hon'ble Chief Minister of Tamil Nadu, among other things, has made the following announcement :-

"தேசிய மக்கள்தொகை பதிவு ஆவணத்திலிருந்து பெறப்படும் குடிமக்களின் உயிரியத் தகவலுடன் கூடிய தனிநபர் பற்றிய தகவல் தொகுப்போடு ஆதார் எண்களை ஒருங்கிணைத்து மாநில குடியிருப்போர் தகவல் தொகுப்பு மையம் ஏற்படுத்தப்பட்டுள்ளது. இந்திய பொது அடையாள எண் ஆணையகம் (Unique Identification Authority of India - UIDAI) ஆதார் பதிவுகளை மேற்கொள்ளும் பதிவாளராக தகவல் தொழில்நுட்பவியல் துறையின் கீழ் இயங்கும் தமிழ்நாடு மின் ஆளுமை முகமையை அங்கீகரித்துள்ளது. குடிமக்களுக்கும், அரசு துறைகளுக்கும் சிறந்த சேவைகளை வழங்கிட ஏதுவாக, ஆதார் பதிவுகளை மேற்கொள்ளவும், மாநில மக்கள் தொகை பதிவேட்டினை பராமரிக்கவும் தமிழ்நாடு மின் ஆளுமை முகமை, மாநிலம் முழுவதும் 650 நிரந்தர பதிவு மையங்கள் அமைக்க நான் உத்தரவிட்டுள்ளேன். இந்த நிரந்தர பதிவு மையங்களை தகவல்

தொழில்நுட்பவியல் துறையின்கீழ் இயங்கும் தமிழ்நாடு அரசு கேபிள் டிவி நிறுவனம் மற்றும் தமிழ்நாடு மின்னணு நிறுவனம் ஆகியவை பராமரிக்கும். முதற்கட்டமாக, இந்நிரந்தர பதிவு மையங்கள், சென்னை மாநகராட்சி மற்றும் அனைத்து வட்டாட்சியா் அலுவலகங்களில் தமிழ்நாடு அரசு கேபிள் டிவி நிறுவனத்தாலும், அனைத்து மாவட்ட ஆட்சியா் அலுவலகங்கள், நகராட்சி அலுவலகங்கள் மற்றும் சென்னை நீங்கலான இதர மாநகராட்சிகளில் தமிழ்நாடு மின்னணு நிறுவனத்தால் செயல்படுத்தப்படும் அரசு இச சேவை மையங்களில் நிறுவப்பட்டு, ஆதாா் பதிவுகள் மேற்கொள்ளப்படும். ஆதாா் அடிப்படையிலான பல்வேறு வகையான அட்டைகள் வழங்கும் பணியும் இம்மையங்கள் வாயிலாக மேற்கொள்ளப்படும். இத்திட்டம் 25 கோடி ரூபாய் செலவில் செயல்படுத்தப்படும்".

- 3. Accordingly, the Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency, in his letter 4th read above, has sent a proposal to Government for establishment of 650 Permanent Enrolment Centres (PECs) at an estimated cost of Rs.32.33 Crores for enrolment of Aadhaar Numbers and Maintenance of State Population Register (SPR) in Tamil Nadu.
 - 4. The estimated cost break up of items in the proposal are as follows:-

- 5. The Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency has further stated that for the procurement of Kits for 650 PECs, the cost has been worked out that each Kit consisting of 1 Laptop, 1 Finger Print Scanner, 1 Iris Scanner and 1 Web Camera costing Rs.1 lakh each per Kit which amounts to Rs.650.00 lakhs. However, for the following items, the amount has been arrived at by multiplying the cost with the rough percentage by taking into account as to how many years it means-
 - Extended Annual Maintenance Contract (AMC) for Hardware (for 2 years) has been worked out from the Hardware cost of Rs.895.34 arrived at 895.34 x 25 % x 2 years which amounts to Rs.447.67 lakhs.
 - AMC for Software (excluding Postgres (For 5 years) has been worked out from the software cost of Rs.523.14 lakhs. Since Rs.400 lakhs is a bundled cost of Postgres, including AMC, the same is excluded for arriving at the AMC for Software and it is worked out as 123.14 x 20% x 5 which amounts to Rs.123.14 lakhs.
- 6. Further, the Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency in his letter fifth read above, has stated that TNeGA had taken over the Aadhaar enrolment from Bharat Electronics Limited (BEL) from 01.10.2016 by setting up of 545 Permanent Enrolment Centres (PECs) throughout Tamil Nadu and for every successful Aadhaar generation and biometric updation made in the PEC, the Unique Identification Authority of India (UIDAI) is paying as per the specified rates and the PEC model is a revenue generating model. Moreover, the PEC Kits employed for Aadhaar enrolment numbering 2,280 have been received from Registrar General of India (RGI)/BEL and there is no hardware cost involved and Manpower and Maintenance are being taken care of the Enrolment Agencies themselves under O&M pattern. Further, for Aadhaar Enrolment of children below 5 years and 5 to 18 years, the funds are met from UIDAL As no fund requirement is needed for implementing the project now since UIDAL funds are to be utilized, the Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency has requested the Government to accord administrative sanction for the project to run the PECs through TACTV, ELCOT and other Enrolment Agencies (EA) as may be necessary.
- 7. The Government, after careful examination, have decided to accept of the proposal of Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency and accord administrative sanction to the Directorate of e-Governance/TNeGA for establishing 650 Permanent Enrolment Centres and to run the Permanent Enrolment Centres through the Enrolment Agencies such as TACTV, ELCOT and other Enrolment Agencies as may be necessary to implement the project. The expenditure estimated at Rs.32.33 Crores, shall met by UIDAI funds.

- 8. The Director of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency is authorised to take appropriate measures as necessary for successful implementation of this project in consultation with concerned Head of Departments and with the approval of TNeGA Board.
- 9. This order issues with the concurrence of Finance (Industries) Department, vide its U.O.No. 14059/IND/2017, dated 22.03.2017.
