ORDER:

In the reference first read above, Government has ordered as follows:-

- a. Administrative approval for the Operations and Maintenance (O&M) of the Tamil Nadu State Data Centre (TNSDC) Phase-I at a cost of Rs.77,23,00,000/- (Rupees seventy seven crore and twenty three lakh only), for a further period of five years from the date of selection of a new Data Centre Operator (DCO) through open tender.
- b. Administrative approval for availing the services of the existing Data Centre Operator (DCO) for the Operations and Maintenance (O&M) of Tamil Nadu State Data Centre (TNSDC) Phase-I, at a cost of Rs.5,56,00,000/- (Rupees five crore and fifty six lakh only) during the Gap Period (maximum 4 Quarters), from the date of completion of the 1st five year period operations of TNSDC on 31.07.2016 till the selection of a new Data Centre Operator (DCO) through open tender.
- c. Approval for renewal of Memorandum of Understanding (MoU) with the National Informatics Centre (NIC) for the Integrated e-Governance Infrastructure Management at State level for a further period of 5 years from 24.10.2016.
- 2. In the letter 2^{nd} read above, the Managing Director, ELCOT has requested the Government to release a sum of Rs.36,53,00,000/- (Rupees thirty six crore and fifty three lakh only) to ELCOT for the 1^{st} year Phase –I-Term II operations of TNSDC.
- 3. The Government after careful examination of the proposal of the Managing Director, Electronics Corporation of Tamil Nadu Limited (ELCOT) sanction and release a sum of Rs.4,17,00,000/- (Rupees four crore seventeen lakh only) towards the Phase –I Term II operations of TNSDC for the period from 01.08.2016 to 30.04.2017.

4. The expenditure sanctioned in paragraph 3 above shall be debited under the following head of account:

2852- Industries- 07 Telecommunication and Electronic Industries - 800-Other Expenditure- Schemes in the Twelfth Five Year Plan II- State Plan - JM. Assistance from State towards establishment of State Data Centre - 09 Grants-in-Aid - 03.Grants for Specific Schemes (DPC 2852 07 800 JM 0939)

- 5. The amount sanctioned in paragraph 3 above shall not be paid in cash but credited to the following head of account through Cheque in favour of Personal Deposit account of the Electronics Corporation of Tamil Nadu Limited.

- 6. The Section Officer (Bills), Information Technology Department is authorized to draw and disburse the amount sanctioned in para 3 above to the Managing Director, ELCOT.

The Managing Director, Electronics Corporation of Tamil Nadu Limited is directed to send the physical and financial progress report of Tamil Nadu State Data Centre (TNSDC) project every month to the Principal Secretary, Information Technology Department along with the details of expenditure and Utilisation Certificate.
- 8. This order issues with the concurrence of Finance (Industries) Department vide U.O. No.11812/Ind/2017, dated 15.03.2017.
