ORDER:

In the Government Order 1st read above, orders were issued according administrative approval to Electronics Corporation of Tamil Nadu Limited (ELCOT) for upgrading the Tamil Nadu State Data Centre (TNSDC) at a cost of Rs.40.00 Crore (Rupees forty crore only) and financial sanction for a sum of Rs.10.00 Crore (Rupees ten crore only) to ELCOT for the 1st year operations of TNSDC - Phase II.

2. In the Government Order 2nd read above, a sum of Rs.8279.00 lakhs has been sanctioned for the TNSDC-1 (Term 2) Operations and Maintenance (O&M) which includes Rs.2600 lakhs for the O&M of 25 racks at BSNL Data Centre for 5 years.

3. In the Government Order 3rd read above, a sum of Rs.5,83,00,000/- was released to ELCOT towards first instalment for the 2nd year operations of TNSDC - Phase -II.

4. In the Government Order 4th read above, a sum of Rs.10,00,00,000/- was released to ELCOT towards second instalment for the 2nd year operations of TNSDC - Phase -II.

5. In the letter 5th read above, the Managing Director, ELCOT has sent a proposal to Government for the following:-

- a. Upgrading of TNSDC (TNSDC-2) at a revised project outlay of Rs.7469.86 lakhs (Rs.2717.64 lakhs over and above the Budget of Rs.4752.22 lakhs already approved).
- b. Approval for utilising Rs.2600 lakhs of O&M charges for BSNL DC already sanctioned under TNSDC-1 (Term 2) O&M for partly financing the upgradation of TNSDC (TNSDC-2).
- c. Approval for sanction of the balance fund of Rs.869.86 lakhs [7469.86 – (4000+2600)] by the Government for upgradation of TNSDC (TNSDC- 2).

6. The Government after careful examination of the above proposal of the Managing Director, Electronics Corporation of Tamil Nadu Limited (ELCOT) hereby accord administrative approval for upgradation of Tamil Nadu State Data Centre -2 (TNSDC-2) at a revised project outlay of Rs.7469.86 lakhs.

7. The Managing Director, Electronics Corporation of Tamil Nadu Limited, Chennai is directed to send necessary proposals to Government justifying the amount required for the current financial year seeking financial sanction.
