ORDER:

In the Government order 1st read above, administrative sanction has been accorded to Tamil Nadu e-Governance Agency for implementation of a portal “namadhuarasu.in” at a cost of Rs.91, 80,400/- for a period of two years to enable the common public to share their views with Government.

2 Further, the Government has directed the Commissioner of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency to send necessary proposal seeking financial sanction for first year operations of this project at the appropriate time.

3. Accordingly, the Commissioner of e-Governance and Chief Executive Officer has sent necessary proposal vide reference 2nd read above for Rs.47,95,400/- towards 1st year instalment as detailed below:

4. The Government after careful examination of the proposal of the Commissioner of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency hereby accord financial sanction for Rs.47,95,400/- (Rupees forty seven lakh ninety five thousand four hundred only) towards first year instalment.

5. Further the Government nominate the Chief Executive Officer, Tamil Nadu e-Governance Agency as Chief Executive Officer of State MyGov Unit.

6. The expenditure sanctioned on para-4 above shall be debited to the following head of account:

7. The expenditure sanctioned in para-4 above shall constitute an item of “**New Instrument of Service**” and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2018-2019. Pending approval of the Legislature, the expenditure will be initially met by drawl of an advance from the Contingency Fund. The Commissioner of e-Governance is authorized to draw and disburse the amount sanctioned in para-4 above to Tamil Nadu e-Governance Agency and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G.I) Department directly in Form “A” appended to Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Commissioner of e-Governance shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2018-2019 at appropriate time without fail.

8. The Commissioner of e-Governance and Chief Executive Office, Tamil Nadu e-Governance Agency is requested to seek the second year instalment at the appropriate time.


